

**TORONTO ULTIMATE CLUB ("TUC")  
Juniors Membership 2010-2011**

**RELEASE, WAIVER & INDEMNITY**

*NOTE: This release form is a contract with legal consequences. Please read it carefully before signing.*

I want to participate in the 2010-11 season of the TUC's activities. I understand and acknowledge that it is my responsibility to follow all of TUC's rules and policies, that the sport of Ultimate may involve physical risk, and that TUC adult leagues and events are unsupervised, not refereed, and not otherwise overseen. I accept the responsibility for inspecting each field on which I play Ultimate in connection with the TUC and satisfying myself as to its safety and confirm that I will take all reasonable cautions for my own safety.

In consideration of the Toronto Ultimate Club accepting me as a participant during the 2010-11 season, I/we, for myself/ourselves, my/our heirs/next of kin, executors, administrators, successors and assigns, hereby release, waive and forever discharge the TUC, its sanctioning body, affiliates, and sponsors and all their respective agents, employees, volunteers, officers and directors, contractors, representatives, elected and appointed officials, successors and assigns (collectively, the "Released Parties"), of and from all liability, injury, loss, death, claims, demands, damages, costs, expenses, actions and causes of action, whether in law or in equity, howsoever caused, arising from or by reason of my participation in the 2010-11 season of the TUC's activities, whether as a spectator, participant, photographed participant, competitor or otherwise, whether to: (i) my person or property; (ii) another person or their property; (iii) TUC, or any event, venue, activity, associates therewith, or; (iv) otherwise (collectively the "Claims").

I/we, for myself/ourselves, my/our heirs/next of kin, executors, administrators, successors and assigns hereby agree to indemnify and save harmless against any and claims arising from and in connection with, my participation in the 2010-11 season of the TUC.

By signing this form, I/we acknowledge having read, fully understood and agreed to the contents of this release, waiver and indemnity, and the attached Juniors Participation Policy. I warrant that I am physically fit to participate in the 2010-11 season of the TUC.

## **TUC Juniors Participation Policy**

The Toronto Ultimate Club (TUC) greatly values its Junior players and works to foster an environment that protects the physical and emotional well-being of players under the age of 19. The purpose of this Policy is to allow properly supervised participation, where appropriate, and to prevent participation where there is potential exposure to overly physical play or inappropriate language.

*There is no TUC appointed supervision for adult leagues or events and there are no referees or convenors on site. Any Junior player who participates in TUC leagues or events, as well as their parent/legal guardian, must acknowledge this fact and waive TUC from responsibility associated with TUC leagues or events. It is the duty of the parent/legal guardian to ensure that if their Junior player is participating in TUC adult leagues or events that they are under the supervision of a Responsible Adult, as defined below.*

### **Definition of a Junior**

- A Junior is defined as a member/participant who is 18 years of age or younger, at any time within the calendar year. If a Junior begins a calendar year at 18 years of age, but then turns 19 years of age at some point during the same calendar year, he/she still qualifies as a Junior member/participant with TUC. If a member/participant is 19 years of age or older throughout the entire calendar year, he/she is considered an Adult member/participant.
- Juniors aged 9-13 are further designated as 'Youth' and members/participants 8 years of age or younger are further designated as 'Children'.

### **Definition of a Responsible Adult**

- A 'Responsible Adult' is a person aged 21 years of age or older, endorsed by the Junior participant's legal guardian, who supervises the Junior participant. It is their duty to ensure that the Junior participant is safe and protected from any environment that is physically or emotionally inappropriate. This responsibility includes full supervision of the Junior throughout the course of his/her participation in the TUC league/event, and possibly removing the Junior from any inappropriate situation.
- A 'Responsible Adult' is declared to the league convenor or tournament/event director, via email or letter from the parent or legal guardian, prior to the start of the league/event. For league, the Junior and Responsible Adult should be declared to the opposing captain prior to the start of the game.

### **Adult League Participation Rules for Juniors**

- Junior aged players who are 16 years of age or older (ages 16 or 17 at the start of a league) may join an adult league team provided they are accompanied by a parent, legal guardian, or other Responsible Adult who is playing on the same team. The parent or Responsible Adult can be playing on the same team or supervising from the sideline, but **MUST** be present for the duration of all games played by the Junior, with TUC. In addition:
  - o The Responsible Adult must be a minimum 21 years of age.
  - o A Responsible Adult, who is not a parent or legal guardian, can only be responsible for up to three (3) Junior players and must be authorized by the parent or legal guardian of each Junior in order to fulfill this role.
  - o Parents or legal guardians can be responsible for any number of Junior players for which they are parents or legal guardians. In addition, they can be responsible for up to one (3) Junior players for which they are not a parent/legal guardian.
- **Any Junior player who is 15 years of age or younger at any point during an adult league, is NOT eligible to participate in TUC adult leagues. Exceptions to this rule are at the discretion of the TUC GM.**

### **TUC Event Participation Rules for Juniors**

- For Junior participants, the rules for adult leagues apply also to TUC tournaments and other events that are not specifically targeted to Juniors.
- The exception to this rule is pickup, which is an informal gathering of ultimate players and is not regulated by TUC. Juniors are permitted to participate in pickup games.

### **Disciplinary Action**

In order to enforce these conditions and foster fair play, we partly rely on the honour system and on our players and team captains. Please abide by the Spirit of the Game when dealing with this (and any other) issue. Remember, these rules are in place to PROTECT a young player from physical and emotional harm, not prohibit them from playing. TUC offers Junior aged leagues for Juniors seeking to play this great game.

If a team does not properly declare his/her Junior player(s) and Responsible Adult(s), or violates the rule above, that team and player are subject to TUC sanctions. The results of all games played with invalid or unsupervised Junior player(s) are disqualified. Individuals/teams committing repeat offences or blatant violations are subject to additional sanctions at the discretion of the TUC GM.
