  - Has the registration process been updated to prompt members to agree to the Fields Fund Contribution as a separate line item on their invoice? YES
  - Met with principal of Ridgeview & director of Capital projects for TDSB to retro-fit for turf field
    - southwest corner of Islington and Eglinton
    - cost could be \$1-\$2 M
    - they will still be meeting with other NFP community groups
  - CTS tax surcharge, Matt R indicated that agreement states that costs can be adjusted due to operational costs
  - Fields permitted vs needed analysis
    - too many fields in inventory
    - Previously, excess inventory had not been returned. Will not be the case going forward
  - League fees may not need an increase
  - Helping Blue procure fields for Goaltimate
  - Women's hat tournament is up
  - Approached by Michael regarding full time hours during "peak season"

  work. Will also need to confirm that "Time and Attendance", "Termination/Resignation" as well as "Progressive
  Discipline" content will be included within the "Discipline/Complaints Policy" or "Code of Conduct" including working
  with Juniors/minors
